Pittsburgh, Pa. – Mark J. He has also been involved in the passage of other significant legislation dealing with Family Law in Pennsylvania.

Goldberg received his undergraduate degree from Washington and Jefferson College and his law degree from Case Western Reserve University School of Law. He was admitted to the Pennsylvania Bar in 1966, to the United States Tax Court in 1969 and to the United States Supreme Court in 1972.
